On arrival clients must inspect their stable and if acceptable a key will be issued in exchange for \$40 Cleaning Bond (cash/chq/ccd) with stamped self addressed envelope. Hay is only permitted in bags. On departure all manure, feed and wet bedding must be removed leaving clean bedding against sides. Stable will be inspected by SEC Staff and if deemed clean, Bond will be issued back. If departing after 6pm Bond will be returned via Post.

Please Note: Cancellations prior to 7 days of the Event will incur a 25% cancellation fee. Any cancellations within 7 days of the Event will not be refunded.
